1.- Who is the data controller concerning the processing of your personal data?

2.- With what purposes do we process your personal data?

3.- For how long will we store your personal data?

Paestum undertakes to process your personal data as long as it is useful and necessary in order to offer you a quality service. Therefore, Paestum will make all reasonable and appropriate efforts to minimize the time it takes to process and store your personal data.

In particular, we would like to inform you that your personal data will be stored using the necessary technical and organisational measures to guarantee the security and integrity of the

data for the following periods of time and, in any case, for as long as you do not request its deletion:

In any case, even if you request the deletion of your personal data, Paestum shall be entitled to keep it and maintain it, under the appropriate blocking, for the necessary time to comply with the corresponding legal obligations, as well as to make it available to the competent Authorities in the different matters which are applicable.

4.- What is the legal basis for the processing of your personal data?

5.- To whom will we disclose your personal data?

Your personal data will not be disclosed to third parties, except to suppliers who provide us services for the proper rendering of the services we provide. Paestum may also disclose your personal data to public bodies and authorities (administrative or judicial) in cases where a legal obligation applies.

By no means will your personal data be communicated outside the European Economic Area.

6.- What are your rights concerning your personal data and how can you exercise them?

At any time, you have the right to access your personal data, as well as to request the rectification of inaccurate data or, where appropriate, to request their deletion when, among other reasons, the data are no longer necessary for the purposes for which they were collected. Under certain circumstances, you may request that we limit the processing of your data, in which case we will only keep them for the exercise or defense of claims.

In certain circumstances and for reasons related to your particular situation, you may object to the processing of your data. Paestum will cease to process the data, except for compelling legitimate reasons, or the exercise or defense of any claims.

You may also exercise your right to the portability of your data and withdraw your consent at any time, without affecting the lawfulness of processing based on your consent prior to its withdrawal.

Finally, we inform you that you may contact the competent Data Protection Authority in your country and other competent public bodies for any claim derived from the processing of your personal data.
